IMPORTANT INFORMATION

- Skips over 6-yards can **ONLY** be used for lightweight materials, therefore, no bricks, soil, stone or tree roots, etc. This also applies for 15yd RoRo's.
- Skip **MUST** be loaded level with the side. The driver has the right to refuse removal if the skip is overloaded and deemed unsafe for travel.

ACCESS

Please ensure there is clear access to the skip location for our driver to easily collect on the requested date.

If we are unable to collect the skip due to access issues you may be liable to pay a wasted journey fee and collection will be postponed until the next available slot.

- X Oil and oil filters**
- X Fuel cans**
- X Paint tins**
- X Chemicals, liquids or fertilisers**
- X Asbestos**
(cement fibreboard must come with a certificate to confirm there is no asbestos, provided prior to collection)
- X Industrial fridge freezers**
- X Wood containing heavy oil base**
(e.g. sleepers or telegraph poles)
- X Batteries**
(inc. children's toys, TV remotes, power tools)
- X Food waste**
- X Fluorescent tubes**

PLASTERBOARD WASTE

Any plasterboard found mixed within a non-plasterboard skip will be charged at the full plasterboard skip rate.

Under the Landfill Directive – 1999/31/EC, it is a legal requirement that no other materials are permitted with plasterboard waste.

Dedicated skips for loose plasterboard are available on request.

Fill-a-bags are available for plasterboard and charged for the collection from site and the cost of the bag.
